

# Sleeper Mechanism

Contract Use Only  
Three (3) Year Warranty

The components from Leggett & Platt, Incorporated ("Leggett") are warranted to the original manufacturer against defects in workmanship and material for three (3) years.

In the event a component is determined by Leggett to be defective in materials or workmanship, and within the warranty period, Leggett, at its option and sole discretion, repair the defect, replace the component or refund the price paid by the original manufacturer for the component.

In no event shall Leggett be responsible for disassembly, installation, or other labor charges. In addition, all packing and shipping charges shall be the responsibility of the manufacturer except during the first year of this warranty, Leggett will pay shipping costs for delivery of the replacement parts or component from Leggett's manufacturing plant to the manufacturer.

Leggett shall have the right to inspect any component and/or to require proof of purchase prior to performing under this warranty.

This warranty does not apply to damage to components occurring after delivery to the manufacturer, including without limitation damage resulting from improper design or manufacture of the furniture in which the component is installed, faulty installation or assembly not in accordance with Leggett specifications, improper service of the components or misuse of the furniture in which the component is installed.

THE REMEDIES PROVIDED IN CONNECTION WITH THIS LIMITED WARRANTY ARE EXPRESSLY IN LIEU OF ANY OTHER REMEDIES PROVIDED UNDER ANY OTHER EXPRESS OR IMPLIED WARRANTY, INCLUDING ANY WARRANTY BY MODEL OR SAMPLE AND ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS, AND OF ANY OTHER OBLIGATIONS ON THE PART OF LEGGETT. IN NO EVENT SHALL LEGGETT BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. NO MODIFICATION OF THIS WARRANTY SHALL BE EFFECTIVE UNLESS IT IS IN WRITING AND SIGNED BY AN AUTHORIZED REPRESENTATIVE OF LEGGETT.

The above warranty is subject to the following conditions: When the defective unit cannot be returned from the field, the following information must be supplied to Leggett prior to exercising the replacement or credit request:

1. The date the sleeper was placed into service.
2. Description of the product failure.
3. Mechanism manufacturing date, branch number, and model type. (This information is located on a data label near the front of the mechanism).

This warranty extends only to the manufacturer. If manufacturer gives a warranty to consumers different from the warranty extended herein, Leggett shall not comply with any portion of that warranty which differs from, modifies, or alters Leggett's warranty.
